

## Information on the lodging tax of the city of Hanover

The city of Hanover will levy a lodging tax from 1 January 2024. We are obliged to pay the lodging tax in full to the city of Hanover. This tax varies depending on the price of the overnight stay and the number of people per room. You can find out about the tax rate applicable to you below. The applicable tax rate is calculated on the room rate (excluding breakfast) and applies to private and business travellers. Minors are exempt from the lodging tax.

### Lodging tax rates for **single room** occupancy

### Accommodation tax rates for multiple occupancy of a room

If a room is occupied by more than one person, the amount for shared accommodation is to be divided by the number of adult guests and allocated to each overnight guest on a pro rata basis as a basis for assessment.

Example: Two adult travellers occupy a room for € 250,00. The pro rata price per adult guest is € 125,00. This corresponds to a tax rate of € 5,35 per person and night, i.e. € 10,70 per room and night.
